Rental agreement

- 5.2. Any repairs needed due to damage or misuse during the rental period are the responsibility of the Renter and will be deducted from the security deposit or charged additionally if the costs exceed the deposit.

6. Indemnity and Liability

6.1. The Renter agrees to indemnify and hold harmless the Lessor from any claims, damages, losses, liabilities, and expenses arising out of or in

connection with the Renter's use of the e-bike.

6.2. The Lessor is not liable for any injuries, losses, or damages to persons or property arising from the use of the e-bike.

7. Termination

- 7.1. The Lessor reserves the right to terminate this Agreement at any time if the Renter fails to comply with any terms and conditions of this Agreement.
- 7.2. Upon termination, the Renter must return the e-bike immediately to the Lessor.

8. Governing Law

8.1. This Agreement shall be governed by and construed in accordance with the laws of the state of Czech Republic.

9. Entire Agreement

9.1. This Agreement constitutes the entire agreement between the parties and supersedes any prior understandings, agreements, or representations, whether written or oral.

10. Helmet Use

10.1. The Renter agrees to wear a helmet at all times while operating the e-bike.

11. Age Requirement

11.1. The Renter must be at least 16 years old.

13. Late Return

13.1. Late returns will be subject to additional charges as defined by the Lessor, based on the duration of the delay. The Renter agrees to pay these charges as specified by the Lessor.
